The eligibility criteria and other terms and conditions for the positions are as under:-



| 2. | Part-time Homeopathic Doctor | 01 (One) | BHMS Degree from any College/University/Institute recognized by the Medical Council of India with at least 03(three) years experience in any Government/Semi-Government/PSUs/Corporations or Trustee Hospital or Government Empanelled Hospitals. |

Terms & Conditions:-

- Emoluments:** Rs. 30,000/- (Rupees thirty thousand only) per month fixed. No TA/DA and other allowances will be paid for the above positions.
- Tenure of Engagement:** The engagement shall be initially for a period of 01 (one) year purely on contract basis from the date of joining and further extendable subject to satisfactory performance & fulfillment of the eligibility criteria and approval of the Competent Authority. The candidate shall have no right to claim for regular appointment at this Institute.
- Timings:** At least for two hours per day on all working days either 9.00 AM to 11.00 AM or 4.00 PM to 6.00 PM or as per schedule issued from time to time. In addition Human Health Complex will also be opened on all Saturdays (except of second Saturday of each month and Gazetted Holidays) from 8.30 AM to 10.30 AM without payment of extra emoluments/remuneration.
- Upper Age Limit:** Maximum age 65 years as on the date of walk-in-interview.
- Place of Posting:** Human Health Complex, ICAR-NDRI, Karnal.
- The Part Time Doctors to be engaged may be called during any weekly off/ holidays in case of any emergency.
- No consultation fee or charge for administering Intramuscular injections can be claimed from the patients.
- No fee shall be charged from the patients for issue of medical/fitness certificate.

9. Only weekly off will be allowed as per contractual labour rules and for Leave or Absence of any other type, the Part Time Medical Doctor will be required to inform the Institute in Advance. The Institute may deduct pro-rata remuneration for such period of Leave or Absence.
10. The Part time doctors shall look the employees (permanent & temporary) and their family members, retired employees and their family members of ICAR-NDRI, Karnal & other ICAR-Institutes who are registered with the Dispensary.
11. The part time doctors have to verify all the medical bills for its reimbursement.
12. The Desirous and eligible applicants will appear to attend Walk-in-interview on **11.04.2025 at 11.00 AM at Jayanti Conference Room of the NDRI, Karnal** alongwith duly filled Application form and resume.
13. The candidates should bring and submit the following documents at the time of walk-in-interview:-
 - i. Duly filled application form;
 - ii. Two latest self attested passport-size photograph (note more than three months old).
 - iii. All the original/final degree certificates starting from Matriculation onwards till highest degree obtained or Provisional Certificate, as the case may be, together with one set of self-attested photocopies.
 - iv. Self attested copy of PAN Card.
 - v. Self attested copy of AADHAR Card.
14. Non production of any of original certificates for verification at the time of interview is liable to rejection of candidature.
15. The candidates may ensure their presence for certificate verification on 11.04.2025 at 11.00 AM at Jayanti Conference Room/Mini Auditorium of ICAR-NDRI, Karnal for Walk in interview. Candidates reporting after 12.00 Noon will not be allowed to appear in the interview.
16. ICAR-NDRI, Karnal will not be held responsible to give regular appointment after expiry of the stipulated period of engagement.
17. The Part-time doctor must adhere the instructions as and when issued by the Competent Authority, ICAR-NDRI is discharging the duties.
18. All the dispute/litigation, if any, will be resolved within the jurisdictions of Karnal (Haryana) Court only.
19. Decision of the Director, ICAR-NDRI, Karnal will be final and binding in all aspects.
